This agreement is made and takes effect on the date of final signature below between the <u>RACINE RAIDERS</u> (hereafter called

- 1. The Team hereby secures the amateur athletic performance services of the Player for a term commencing on the date of this agreement and Player hereby accepts such to be a member of the Team as a roster participant/player. By signing this contract, the player understands that they are locked to this member team for the 2025 Players Football Association ("PFA") season unless written release is granted by Team.
- 2. During the Player's tenure as an amateur athlete and member of the Team he/she will:
 - A] Devote such time and effort as may be reasonably required by the Team to perform his/her physical duties as an active participant and/or athlete.
 - B] Not engage in any other organized athletic event or athletic activity without the Team's written consent.
 - C] Perform such duties as may reasonably be required of him/her by the Team. This includes, but is not limited to, full Player participation in Team games, meetings, community service projects, events, etc.
 - D] Not participate as a player on the roster of any other organization like the Team, regardless of league, association, affiliation, or professional or amateur status, etc., while listed as member of the Team roster and while the Team is still "actively" competing in its current season.
 - E] Shall obey and/or abide by any and all rules, policies, orders, directives, etc., written or otherwise, established by the Team and/or the Players Football Association. This includes, but is not limited to, the prompt payment of all disciplinary fines and/or fulfillment of suspensions assessed by the Team and/or the Players Football Association.
 - F] Shall sign a "Waiver of Liability/Hold Harmless" form as required by the Team and the Players Football Association.
 - G] Shall return any and all uniforms and/or equipment issued to the Player by the Team upon request of the Team. This includes, but is not limited to, Team playbook and/or documents, files, etc., considered to be exclusive real property of the Team
 - H] Shall reimburse the team for any Players Football Association fees related to "Player Registration," "Player participation," or other fees associated with the Team or Players Football Association before being released from this contract.
 - I] Shall participate in at least two (2) community events in the calendar year of this Contract.
 - 6. Player understands that he/she may and/or will acquire confidential information of strategic value to the Team during the course of his/her tenure. Other than in the performance of activities and events beneficial to the Team, Player hereby agrees not to divulge such confidential information to any other party, or to use such information for his/her own profit.
 - 6. Player's tenure shall automatically terminate on December 1, 2025, or upon his/her death; inability or failure to perform the duties required by this agreement, or his verbal/written notice of resignation and/or departure given to the Team. Following termination of the Player's tenure and/or participation with the Team, all obligations, financial or otherwise, that have not been satisfied to the Team, must be fulfilled before the Player is permitted to sign a similar agreement with any football organization, and subsequently participate with same. Failure to do so will result in a "breach" of this agreement by the Player and thus permit the Team to collect the amount of financial obligation due to the Team, including but not limited to, any and all legal expenses exhausted by the Team as a result of collecting such debt from the Player.
- 5. This agreement constitutes the entire agreement between Team and Player once it is signed.
- 6. This agreement shall be interpreted and, if necessary, adjudicated in accordance with the laws of the Racine Raiders Football Club, Inc. and/or Players Football Association.
